8) **ELMOTION:-**

Managing Committees. In his/her absence or inability, the President can ask any one of the Trustee to act and discharge the duties of the President by a Written Order, and the President will have the Power to appoint his successor.

10) VICE-PRESIDENT:-

In the absence of the President, the Vice-President will discharge the normal duties of the President.

11) SECRETARY:-

The duties entrusted by the President and other day-to-day normal correspondence are to be discharged by the Secretary. Any financial responsibility should be done in consent with the President. It shall be the duty of the Secretary to summon under the instructions of the President and to enter minutes of all the proceedings of such meetings in a Minute Book and same shall be signed by the President on confirmation.

12) TREASURER:- 10 -

13) THE QUORUM:-

14) FRAMING OF RULES & BYE-LAWS:-

15) AMENDMENT CLAUSE:-

No amendment of Trust and Rules Regulations, Byelaws shall be made, which may prove to be repugnant to the Provisions of Section 2(15) 11, 12, 13 and 80G. of the Income Tax Act 1961. No amendment shall be carried out without the prior approval of the Commissioner of Income Tax. All amendments to the Trust Deed shall be registered with sub-Registrar under Indian Trust Act.

16) ACCOUNTS:-

The Board of Trustees and Managing Committee shall duly maintain true and correct accounts of all assets, dispossals, receipts and expenses of the Trust. The funds/ donations/contributions received by Trust in cash or kind,
